**AMENDED SALARY RESOLUTION FOR THE

Accounts Manager/ Personnel Officer	\$30,000.00 to \$65,000.00 per year
Accounts Receivable Administrator	\$30,000.00 to \$65,000.00 per year
Economic Development Coordinator	\$30,000.00 to \$85,000.00 per year
Recording Secretary	\$5,000.00 per year maximum
Safety Director	\$2,000.00 to \$6,000.00 per year
Meter Replacement Program	\$2,000 to \$5,000.00 per year
Backup Operator of Record Collection System	\$1,000.00 to \$2,000.00 per year
Backup Operator of Record	\$1,000.00 to \$2,000.00 per year

**WHEREAS**, certain hourly employees shall be compensated as follows:



Part Time	\$10.00 to \$16.00 per hour
