**RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL
UTILITIES AUTHORITY MEMORIALIZING THE DISCONTINUATION OF THE
CREEK LANE WATER EXTENSION PROJECT**

WHEREAS, the Mantua Township Municipal Utilities Authority (“MTMUA”), has its principal place of business at 397 Main Street, Mantua, New Jersey 08051; and

WHEREAS, the purpose of MTMUA is the provisioning of water and sewer services to the residents of Mantua Township; and

WHEREAS, on April 20, 2021 the MTMUA held their regular meeting and discussed the potential expansion of the water services to the residents of Creek Lane; and

WHEREAS, on April 20, 2021, residents of Creek Lane attended the regular meeting of the MTMUA to voice their opinion both in support of and not in support of any proposed water extension to Creek Lane with a considered majority voicing disapproval of such an extension of water service; and

WHEREAS, in light of conflicting opinions on extending water service to Creek Lane, the MTMUA on April 26, 2021 sent out an investigatory survey by certified mail regarding the potential expansion project to the 23 residential addresses of Creek Lane with a response date of May 14, 2021; and

WHEREAS, at the regular meeting of the MTMUA on May 18, 2021, the MTMUA Director shared the results of the survey which may be summarized as: five (5) residents had responded **YES** or in support of the extension, twelve (12) residents had responded **NO** or not in support of the extension, and six (6) residents simply had not responded; and


WHEREAS, in light of the results of the aforementioned survey where the majority of Creek Lane residents are not in favor of extending water service to Creek Lane, the Commissioners directed the MTMUA Director to send a letter to the residents advising them that the MTMUA shall not move forward with any extension of water service to Creek Lane; and

NOW, THEREFORE, BE IT RESOLVED, to the following:


